**BERKLEY/PENDELL PIANO COMPETITION**

The 2008 piano competition will again be held at the McAninch Arts Center, College of DuPage. The date for this year's competition is Saturday, April 26, 2008. Application deadline is a postmark date of Friday, March 21, 2008. I would like to encourage all teachers to consider entering students in this wonderful opportunity that the Berkley/Pendell Fund provides for the local associations.

Marilyn Anderson announces that the Berkeley-Pendell Piano Competition rules are about the same as last year except for how to get the 5 points. See the flier on the table, point distribution below, or contact Marilyn at 630-834-2704 for the details. Teachers who plan to enter students in this year's piano competition need to accumulate five points by the application deadline, March 21, in order to fulfill their teacher eligibility. The points for this year have been changed slightly and are as follows:

- 1. Board members within local associations, state, or national..... 4 points
- 2. Attend association monthly meeting ..... 1 point
- 3. Act as a speaker or panel member at a monthly meeting ..... 3 points
- 4. Serve as chairperson for a chapter recital ..... 1 point
- 5. Serve 3 or more hours at AIM exam..... 1 point
- 6. Attend a workshop offered by the joint area group or state or national .1 point per day

**AIM WORKBOOK PRICE INCREASE**

Beginning January 1, 2008, all AIM workbooks will increase in price by one dollar. Thus, levels II-V will cost \$6 (instead of \$5) and levels VI-XI will cost \$7 (instead of \$6). In addition, the cost of the AIM Piano Syllabus will increase from \$25 to \$28, and the Teacher's Guide will increase from \$15 to \$18. This increase, approved unanimously by the state Governing Board at our fall meeting, will offset increasing printing and packaging costs. The shipping costs will also be raised slightly to reflect recent postage rate increases. Your understanding is greatly appreciated!

New ISMTA Newsletter Policy

**New ISMTA Newsletter Policy Detailed at [www.ismta.org](http://www.ismta.org)**

Beginning in January with our Winter 2008 edition, all current ISMTA members will receive their newsletters electronically. We regret that we will no longer be mailing out all of our issues due to ever-increasing printing and postage costs. Your understanding is very much appreciated.

The state office is asking us to make sure our ISMTA Newsletters are not blocked by spam filters. Spam filters keep unwanted/unsolicited e-mail out of your in-box. That's generally a good thing. A problem can arise, however, when your idea of spam doesn't match your e-mail client filter's idea of spam. A way to avoid having your ISMTA newsletter relegated to your Bulk Mail folder (without you even knowing the newsletter arrived), is to "white list" the address "[matt@ismta.org](mailto:matt@ismta.org)." White listing just means you are telling your spam filter, "Hey, make sure that any e-mail from Matt at the ISMTA Central Office, including my newsletter, isn't mistaken for spam!"

Every e-mail client has a different procedure for white listing an address. I use Yahoo mail for my personal account. Their procedure involves going to "Options," then "Filters," and then following a few simple instructions from there. Again, every e-mail program is a little different, so you may have to dig around a bit for your personal solution or ask a technically savvy member for assistance.



## AIM PERFORMANCE EXAM INFORMATION 2008

Performance exams for all levels, 1A, 1B, 1C through 12 will be given on Saturday, March 8, from 8:00 a.m. to 5:00 p.m. at McAlister Hall, Wheaton College. The deadline for submitting enrollment and repertoire sheets is Thursday, February 7<sup>th</sup>. Copies of these forms can be found in the 2005 handbook or our chapter website, [www.wsismta.org](http://www.wsismta.org).

ENROLLMENT SHEETS: Please duplicate your enrollment sheets and return 3 copies with student's names and levels following these instructions. The first two columns should remain blank.

- \* Alphabetize all students by last name (Brown, James).
- \* Please type or print legibly.
- \* Place an asterisk before the names of students who are participating for the first time.
- \* The fees for levels 1A, 1B, 1C, and 2 are \$15.00 (Fees for levels 3-12 were already paid last fall).
- \* Include one check made out to WEST SUBURBAN ISMTA for all fees. Have your student reimburse you.
- \* Use Arabic numbers (NOT ROMAN NUMERALS) to indicate levels.
- \* If a student needs a morning or afternoon time, two or more family members coming together, or a student needs a make-up, please indicate the reason in writing on the enrollment sheet. **DO NOT ATTACH NOTES!**

REPERTOIRE SHEETS: Submit only one sheet per student. Please follow these instructions:

- \* Type or print legibly
- \* Use Arabic numbers (NOT ROMAN) to indicate levels.
- \* Be sure the pages listed are SYLLABUS pages and not the page numbers of individual piano books.
- \* All repertoire must be from the new (2003) AIM repertoire list. (See below for substitutions).

MEMORY POINTS: From level 4-12, two "memory pieces" are the stated syllabus requirement. If additional piece(s) are memorized, additional bonus points will be added allowing for a possible total score in excess of 100 points.

REPERTOIRE SUBSTITUTIONS: The deadline to request substitutions is January 15. Please send a copy of the piece (first and last pages if long) plus a written request to : *Marie Rutter, 1731 Epping Place, Schaumburg, IL, 60194-4010*. If more than one request is included, please be sure that they are organized according to level and list. Pieces on the National Federation lists do not need approval by Marie Rutter, but do need approval for level by Rita Brown. **Any repertoire from past syllabus lists that are not on the current, revised list (2003) must be approved by Marie Rutter.**

UPPER LEVEL JUDGES: There is a special need for your services. Two judges are required for level 12 if an AIM Exam is taken in lieu of a recital.

STUDENTS: All students taking the Performance Exams levels 3-12 must have taken the Theory Exam this past fall 2007. Students in levels 1A-8 will receive a certificate, level 9 will receive a plaque, and higher levels will receive a bar to add to their plaque. The average score for theory and performance needs to be 80 or higher to qualify for the plaque and bars.

## TEACHERS:

- \* All teachers who enter students are required to give at least 4 hours of judging time on March 8.
- \* All judges **MUST** attend the Judging Session, which is **DURING THE PROGRAM TIME** (9:50-11:15 a.m.) immediately following the business meeting on January 10, 2008. This is earlier this year than previous years!
- \* All teachers must attend **TWO** complete business meetings and programs before the Performance Exams.
- \* All fees are non-refundable.
- \* You will receive a copy of the enrollment sheet listing the time and room number for each of your students 1-2 weeks before the exam. No changes in schedule will be made after Sat. March 1.
- \* **Reminder: BE SURE YOU ARE USING THE REVISED TECHNIQUE REQUIREMENTS (2003) FOR ALL LEVELS. The fingering listed in the syllabus (pages A-11 to A-13) is to be used for technique, unless a form for alternate fingering is submitted by the teacher (form available at meetings).** There are no longer any oral questions at any level. Sight-reading will only be for levels 1A, 1B, 1C, and 2.

## LEVEL 11 AND 12 RULE CHANGES (made in 2006):

1. Of the four required style period pieces in Level XI, 3 pieces must be chosen from the XI (or XII) repertoire list. The required 4<sup>th</sup> style period piece may be chosen from Level X. For example, a student who has already chosen a Classical, a Romantic, and a Contemporary piece, but is having trouble finding a Baroque piece may choose an easier Baroque piece from Level X. Alternatively, a student who has already chosen four pieces this year, but is finding the Impressionist piece too difficult, might consider replacing it with an easier piece from Level X.
2. Of the four required style period pieces in Level XII, 3 pieces must be chosen from the XII repertoire list required 4<sup>th</sup> style period piece may be chosen from Levels X or XI. Level XII students must play 3 pieces from the XII repertoire list, but may look back to X or XI for the required 4<sup>th</sup> style period piece.
3. There is no longer a 30-minute minimum playing time for the XII exam or recital. (Some of the more difficult pieces are short.)

## REMINDER NOTES:

In addition to the required four new pieces from four style periods that are evaluated for a Level XII recital, the student may choose to perform additional pieces he or she has performed at earlier levels, or even end with a "Novelty" or ensemble piece.

While sending in the Level XII program for Marie Rutter's approval, teachers should also send a copy of the previous year's Level XI program **ONLY** if the student chose to perform the Sonata-Allegro movement the previous year.
